Submission of Online Application Form for Preparation of State Merit List on the basis of JEE(Main)-2023 Result for Conducting First, Second & Third (Last) Round of Online Counselling

PRESS COMMUNIQUE

Online Application Forms are invited from candidates having rank in JEE (Main) – 2023 for preparing the State Merit List for conducting the Counselling for admission in different branches of B.E./B.Tech. Course of Engineering Institutes of Jharkhand State (List of Engineering Institutes for academic year-2023-24 is uploaded on the Board's website). The candidates must meet the following eligibility criteria:-

1. **Educational Criteria:-** The Candidate must have passed 10+2 examination with Physics/Mathematics / Chemistry / Computer Science / Electronics / Information Tech./ Biology/Informatics Practices/Biotechnology/Technical Vocational subject/Agriculture /Engineering Graphics/ Business Studies/Entrepreneurship as per table 1.3(a) & obtained at least 45% marks (40% marks in case of candidates belonging to reserved category) in the above subjects taken together OR Passed D.Voc. Stream in the same or allied sector. (As per AICTE Approval Process Handbook 2023-24).
2. **Residential Criteria:-** The Candidate must be a citizen of India and Local/Permanent resident of Jharkhand. The "Local Resident of Jharkhand" has been defined & identified in 7/Aa. Niti (Sarvdaliaye Baithak) 27/2002 (Khand)ka.-3198/, dated 18.04.2016 of Personnel, Administrative Reforms and Rajbhasa Department, Govt. of Jharkhand.

Local Resident Certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State] is required at the time of admission in the concerned allotted Institute.

- 3.(a) **Reservation on Caste Basis:-** The current reservation policy of Govt. of Jharkhand will be followed for admission in Institutes. Caste certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State] is required for candidates claiming reservation.

Candidates belonging to BC – I & BC – II, will have to produce the caste certificate as per Letter no. 14/Ja.Ni.-03-13/2015/Ka.-1754 dated 25.02.2019 of Deptt. Of Personnel, Administrative Reforms and Rajbhasa, Govt. of Jharkhand. Caste certificate produced by BC – I & BC – II Candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned in caste certificate.

(b) **Reservation for Economically Weaker Sections (EWS):-** Candidates from Economically Weaker Sections can avail benefits of reservation as per Memorandum (Memo No.-14/Aa.Ni.-04-02/2019/Ka.-1434 Dated 15-02-2019) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

Income & Assets Certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State] is required for candidates claiming reservation.

(c) **Reservation for Person with Disabilities:-** Divyang candidates can avail benefits of reservation as per Memorandum (Letter No. 2249 Dated 03.04.2018) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

Disability Certificate in proper format, issued by competent authority [Chairman of the Medical Board & Countersigned by Medical Superintendent/Chief Medical Officer/ Head of the Hospital of Jharkhand State] is required for candidates claiming reservation.

(d) **Reservation for Service Man Quota (SMQ):- :-** Dependency Certificate issued by Competent Army Personnel for Serving Personnel / Dependency Certificate issued by Zila Sainik Kalyan Board for discharged Personnel/ Discharge Book/Pension Book /Certificate as per their preference code is required for candidates claiming reservation.

(e) **Reservation for Primitive Tribal Groups Candidates :-** Candidates from primitive tribal groups can avail benefits of reservation as per Memorandum (Letter No. 5555 Dated 28.06.2016) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi.

(f) **Tuition Fee Waiver Scheme:-** As per AICTE, New Delhi, 5% Supernumerary seats are available for candidates in each branch. Income Certificate of upto Rs. 8 lacs, issued by Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State is required for candidates claiming reservation.

The Notification/Memorandum copy and format of all the above certificates are available under "Act & circulars" and "Download" column on the Board's website.

4. **While filling up the online application form, the eligible candidates from reserved category/quota should claim benefits of reservation and/or scheme only when they already possess the concerned certificate issued in the proper format by the competent authority. The Certificate issued by any authority other than competent authority and in format other than prescribed will not be entertained.**

5. **The Board will prepare the State Merit List on the basis of JEE(Main) – 2023 Result & claim made by the candidates in the online Application form.**

6. Interested eligible candidates are requested to fill the **Application Form Online** on Board's website <http://jceceb.jharkhand.gov.in> by Clicking on "Click here for All Online Application Submission – JCECEB 2023" tab by following the given directions as per below schedule :-


9. **Candidates who have been recommended for admission, will have to submit all concerned original certificates/documents as per their seat allotment failing which their Provisional Seat Allotment Letter will be deemed cancelled.**
10. Candidates who are admitted on the basis of 1st and/or 2nd round of online Counselling and want to change branch and/or institute against the remaining vacant seats can appear in 2nd and/or 3rd (final) Counselling respectively. If the seat is re-allocated in the concerned Counselling/Counsellings, it will be mandatory for the candidate to get admitted in the newly allotted branch and/or institute as their earlier admission will automatically be cancelled and the seat thus vacated will be allotted to another candidate on merit-cum-choice basis by the Board.
11. **Registration/Application & Counselling Fee:-** Candidate will have to pay Registration /Application & Counselling Fee through Payment Gateway by Credit Card/Debit Card/Net Banking/UPI as given below:-

12. **Partial Admission Fee for Seat Allotment Letter** :-It is mandatory for candidates to deposit Rs.1000/- as described in Clause-11 for downloading the Provisional Seat Allotment Letter. If such candidates take admission in allotted Institute & continue their study, then the partial Admission Fee will be made available to the concerned Institute for adjustment as tuition fee otherwise Partial Admission fee will be seized by the Board. Candidate will not have to pay the Partial Admission fee for change in branch and/or institute if he/she has already been admitted in the institute/college as per merit list prepared by the Board.

13. The vacant seats under different category/categories will be exchanged in Third (Last) Round of Online Counselling as per the provisions of Department of Personnel, Administrative Reforms and Rajbhasa, Govt. of Jharkhand in case of unavailability of reserved category candidates.
